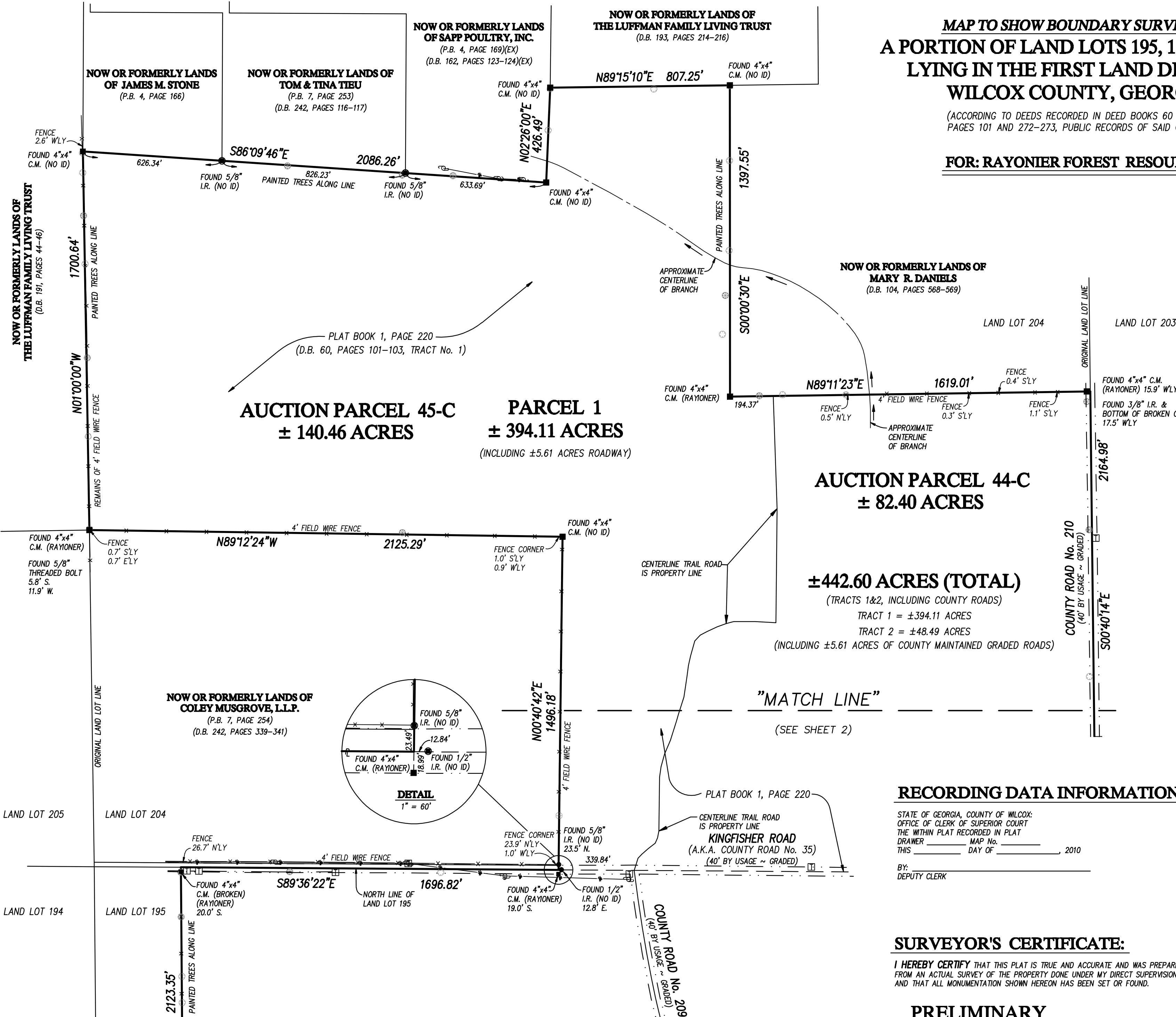
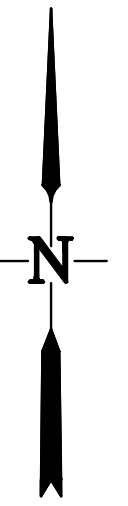


**MAP TO SHOW BOUNDARY SURVEY OF

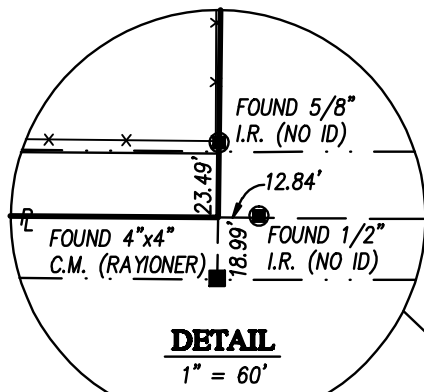

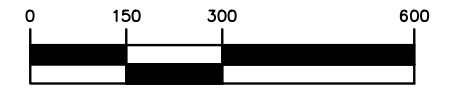
