Rayonier Forest Resources, L.P., successor by name change to Rayonier Timberlands Operating Company, L.P., a Delaware limited partnership, also known as RTOC, Limited Partnership, a Delaware limited partnership, by virtue of that certain Quit Claim Deed from ITT Rayonier Incorporated, a Delaware corporation, dated November 19, 1985, filed September 29, 1987, and recorded in Deed Book 198, Page 761, Dodge County, Georgia records; by virtue of that certain Affidavit of Title, by Tracy K. Arthur, Assistant Secretary of Rayonier Forest Resources, L.P., a Delaware limited partnership, dated February 11, 2009, filed February 13, 2009, and recorded in Deed Book 627, Page 72, aforesaid records.

Tract 1:

That tract or parcel of land situate, lying and being in lot of land number one hundred fourteen (114) in the 20th Land District of Dodge County, Georgia, and being ninety four and ninety-five hundredths (94.95) acres, more or less of said lot as described in the plat of a survey thereof made January 8, 1964 by Harrell & Ross, Surveyors, Georgia License No. 109, as the same is recorded in office Clerk Dodge Superior Court in Plat Book 5, Page 263, which plat and the record thereof are by reference incorporated herein, and as follows: Beginning at the original East corner said lot and running thence along a fence on the Northeast lot line North 44 degrees West 1500 feet to a stake; thence South 46 degrees West along a fence 2700 feet to a stake; thence South 44 degrees East 516 feet to a stake; thence South 46 degrees West 300 feet to the original Southwest lot line of said lot; thence along said line South 44 degrees East 371 feet to the public road known as the River Road; thence along said road North 88 degrees East 916 feet to the original Southeast line of said lot; thence along said Southeast lot line and a fence North 46 degrees East 2320 feet to the East corner the Point of Beginning.

All that tract or parcel of land situate, lying and being in the 20th Land District of Dodge County, Georgia and being that part of lot of land number one hundred fifteen (115) described as begin at the South corner of said lot and run the Southwest lot line North forty-five (45) degrees West a distance of two thousand nine hundred seventy (2970) feet to the West corner of said lot; thence along the Northwest lot line North forty-five (45) degrees East a distance of three thousand (3000) feet to the North corner of said lot; thence along the Northeast lot line South forty-five (45) degrees East a distance of one thousand four hundred ninety-four (1494) feet to lands of Mrs. A. J. Price; thence in a direction of South forty-five (45) degrees West a distance of one thousand four hundred seventy-six (1476) feet; thence in a direction of South forty-five (45) degrees East a distance of one thousand four hundred seventy-six (1476) feet to the Southeast lot line of said lot; thence in a direction of South forty-five (45) degrees West a distance of one thousand five hundred twenty-four (1524) feet to the South corner, the Point of Beginning.

SCHEDULE B - SECTION I

REQUIREMENTS

The following requirements must be met:

1. Pay the agreed amounts for the interest in the Land and/or mortgage to be Insured.
2. Pay us the premiums, fees and charges for the policy.
3. Pay all taxes and/or assessments, levied and assessed against the land, which are due and payable.
4. You must tell us in writing the name of anyone not referred to in this commitment who will get an interest in the Land or who will make a loan on the Land. We may then make additional requirements or exceptions.
5. Documents satisfactory to us creating the interest in the Land and/or the Mortgage to be insured must be signed, delivered and recorded.
 - a. **Limited Warranty Deed from Rayonier Forest Resources, L.P., successor by name change to Rayonier Timberlands Operating Company, L.P., a Delaware limited partnership, also known as RTOC, Limited Partnership, a Delaware limited partnership, in a form approved by the Company, to To Be Determined** conveying interest in subject property.
6. As to the execution of the aforementioned Deed(s), the Company requires proof, satisfactory to us, that:
 - a. Owner is duly organized and validly existing as a limited partnership under the laws of the State of Delaware and, to the extent that "qualification" has application to limited partnerships, has qualified to conduct business in the State of Georgia. (NOTE: We require a true, complete and correct copy of both the Certificate of Limited Partnership and the Limited Partnership Agreement of Owner, together, in each case, with copies of all amendments and exhibits thereto.)
 - b. The general partner of Owner who will execute the Deed(s), if an entity other than a natural person, is organized, existing and in good standing; is qualified to conduct business in the State of Georgia; is incumbent in the position of general partner; and, that all necessary partner (general and limited) and partnership action has been taken to authorize conveyance of the land as security for indebtedness and that all consents thereto, if necessary or required, have been obtained.
 - c. The officer or officers of the general partner, if the general partner is not a natural person, is or are incumbent in the offices which they purport to hold.

7. Evidence of the good standing of Owners and, as appropriate, of the Insured, and of the incumbency and authority of the officers of Owners and of the Insured who will execute the instrument of conveyance.
8. Execution and delivery to us of an Owner's Affidavit, in context to the transaction. NOTE: if brokers are involved in this transaction, we will require evidence of release and satisfaction of broker's liens.
9. A current and accurate survey of the land, certified to the Company, to the Insured, and to the Lender, if we are expected to delete or modify the general survey exception.
10. Proof satisfactory to the Company that no improvements or repairs were made upon the land within the 95 days preceding the filing for record of the instrument creating the interest to be insured, or in the event such improvements or repairs were made, that they are completed and that all costs incurred in connection therewith have been fully paid; that there are no easements or claims of easements which do not appear of public record; and that there are no parties in possession or with a right to possession of the subject property.
11. No Outstanding Deed to Secure Debt of record - Please Inquire.
12. The Georgia Commercial Real Estate Broker Lien Act applies to a sale, lease, option, loan or other transfer of commercial real estate. The Company must be provided proof, in affidavit form from the Seller and Purchaser, satisfactory to the Company, (a) of payment in full of any broker's services which have been engaged with regard to the management, sale, purchase, lease, option or other conveyance or proposed conveyance of any interest in the subject commercial real estate, together with a lien waiver or estoppel letter from any party determined by such affidavit to have a right to file a broker's lien, and (b) that no notice of lien for any such services has been received. In the event that said affidavit(s) contain any qualification with respect to any such services, proof of payment in full for all such services, together with a lien waiver or estoppel letter from such identified Broker(s) must be obtained.

NOTE: Where the possibility of a right to file a broker's lien is determined and no lien waiver or estoppel letter provided to the Company, the following exception will be included in the policy to be issued pursuant to this Commitment.

Any broker's lien, or right to a broker's lien, imposed by law.

13. Based upon information developed or received in satisfaction of the above, the Company reserves the right to impose additional conditions or to set new requirements.

SCHEDULE B - SECTION II

EXCEPTIONS FROM COVERAGE

Any policy we issue will have the following exceptions unless they are taken care of to our satisfaction.

1. Taxes or assessments of any taxing authority that levies taxes or assessments on real property.
2. Any facts, rights, interests, or claims that are not shown by the Public Records but that could be ascertained by an inspection of the Land or that may be asserted by persons in possession of the Land.
3. Easements, liens or encumbrances, or claims thereof, not shown by the Public Records.
4. Any encroachment, encumbrance, violation, variation, or adverse circumstance affecting the Title that would be disclosed by an accurate and complete land survey of the Land and not shown by the Public Records.
5. Any mineral or mineral rights leased, granted or retained by current or prior owners.
6. Taxes and assessments for the year 2010, which are not yet due and payable and taxes for prior years arising from re-assessments or digest disputes.

NOTE: The 2009 State and Dodge County, Georgia taxes are due and payable in the amount of \$1,735.01 on December 20, 2009 for tax map reference no. 033-020.

NOTE: The 2009 State and Dodge County, Georgia taxes are due and payable in the amount of \$1,056.13 on December 20, 2009 for tax map reference no. 033-020A.

7. Defects, liens, encumbrances, adverse claims or other matters, if any, created, first appearing in the public records or attaching subsequent to the effective date hereof but prior to the date the proposed Insured acquires for value of record the estate or interest covered by this Commitment.
8. Any lien, or right to a lien, for services, labor, or material heretofore or hereafter furnished, imposed by law and not shown by the public records.
9. Although the Policy will insure the location of the boundaries of the land, no insurance is afforded as to the amount of area contained within said boundaries.
10. Rights of upper and lower riparian owner's in and to the waters of any creek or stream which bounds or traverses the land, free from increase, decrease or pollution.
11. Rights of tenants in possession, as tenants only, under unrecorded occupancy agreements.
12. Reservation of Mineral Rights contained in that certain Quit Claim Deed from ITT Rayonier Incorporated, a Delaware corporation to Rayonier Timberlands Operating Company, L.P., a Delaware limited partnership, also organized under Georgia law, in which state it is known as

RTOC, Limited Partnership, dated November 19, 1985, filed for record September 29, 1987, and recorded in Deed Book 198, Page 761, Dodge County, Georgia records.

13. Easements for drainage and maintenance as conveyed in Right of Way Deed from ITT Rayonier, Incorporated to Dodge County, Georgia, dated January 6, 1969, filed for record May 12, 1969, and recorded in Deed Book 107, Page 575, aforesaid records.
14. Any implied easements for slopes, fills, drainage, maintenance, and utilities as conveyed in Right-of-Way Deed, from Guy J. Tripp to Dodge County, Georgia, dated June 6, 1955, filed for record March 5, 1957 and recorded in Deed Book 75, page 433, aforesaid records.
15. Matters as shown on plat recorded in Plat Book 5, Page 263, aforesaid records. (Tract 1)
16. Matters as shown on plat recorded in Plat Book 6, Page 231, aforesaid records. (Tract 2)
17. Matters as would be disclosed by a current and accurate survey and inspection of the subject premises.

CONDITIONS

1. DEFINITIONS

(a) "Mortgage" means mortgage, deed of trust or other security instrument. (b) "Public Records" means title records that give constructive notice of matters affecting your title according to the state statutes where your Land is located.

2. LATER DEFECTS

The Exceptions in Schedule B - Section II may be amended to show any defects, liens or encumbrances that appear for the first time in the public records or are created or attach between the Commitment Date and the date on which all of the Requirements (a) and (c) of Schedule B - Section I are met. We shall have no liability to you because of this amendment.

3. EXISTING DEFECTS

If any defects, liens or encumbrances existing at Commitment Date are not shown in Schedule B, we may amend Schedule B to show them. If we do amend Schedule B to show these defects, liens or encumbrances, we shall be liable to you according to Paragraph 4 below unless you knew of this information and did not tell us about it in writing.

4. LIMITATION OF OUR LIABILITY

Our only obligation is to issue to you the Policy referred to in this Commitment, when you have met its Requirements. If we have any liability to you for any loss you incur because of an error in this Commitment, our liability will be limited to your actual loss caused by your relying on this Commitment when you acted in good faith to:

Comply with the Requirements shown in Schedule B - Section I

or

Eliminate with our written consent any Exceptions shown in Schedule B - Section II.

We shall not be liable for more than the Policy Amount shown in Schedule A of this Commitment and our liability is subject to the terms of the Policy form to be issued to you.

5. CLAIMS MUST BE BASED ON THIS COMMITMENT

Any claim, whether or not based on negligence, which you may have against us concerning the title to the Land must be based on this Commitment and is subject to its terms.



PRIVACY POLICY

We Are Committed to Safeguarding Customer Information

In order to better serve your needs now and in the future, we may ask you to provide us with certain information.
